Course Description

This course will review sociological perspectives on youth criminal offending and on the legal and moral regulation of youth. Canadian social policies with respect to the criminal behaviour of young persons will also be examined.

Prerequisite(s): 1.0 from Sociology courses at the 1000 level.

Learning Outcomes

By the end of this course students should have gained a solid understanding of the main elements of the youth justice system and the ways in which it operates in Canadian society. Students should be able to identify and critically assess both the historical formation of the youth criminal justice system as well as its progression over time, both in Canada and internationally (with some focus on the USA). In addition, students will gain an understanding of differing theories and perspectives used in sociology to understand and explain youth in conflict with the law.

Brescia Competencies

At the end of this course students will:

1. Have a working knowledge of the evolution of legislation regarding young offenders. (Core competencies: Inquiry and Analysis)
2. Be able to understand, utilize, and present criticisms of sociological and criminological theories of youth crime. (Core competencies: Critical Thinking; Inquiry and Analysis; Problem Solving; Social Awareness and Engagement; Valuing)
3. Understand how young offenders are processed through all tiers of the criminal justice system, including contact with police, diversion programs, the courts, and the correctional system. (Core competencies: Inquiry and Analysis)
4. Be able to critically analyze the impact that policy and legislation have on young people and how this has changed over time. (Core competencies: Critical Thinking; Inquiry and Analysis; Problem Solving; Self Awareness and Development; Valuing)
5. Be able to write a theoretically-informed analysis of a youth criminal event as reported in either print or electronic journalism. (Core competencies: Communication; Inquiry and Analysis; Valuing)

This course will not only be helpful to students who major in the social sciences, but also to counsellors, social workers, police officers, teachers, parents and students of law.

Teaching Methodology and Expectations of Students

Course Delivery

This course will be run online asynchronously (non-real-time). Each week I will post “mini lectures” (20-30 minutes in length), readings, documentaries, quizzes, and assignment details on our course OWL site (<https://owl.uwo.ca/>). Each week will have “checklist” provided to make sure that you are keeping up with the material/tasks that are assigned each week. Lectures and course readings are meant to be reviewed at your own pace each week. I have decided against Zoom classes at specific times to ensure flexibility and inclusivity in this course. I realize specific times can be challenging with everything else going on in your life at this time. It is recommended that you review these materials early in the week to prepare for the exercises and quizzes. You will also use our OWL site for engaging in class discussion, uploading your completed exercises and assignments, reviewing feedback on graded materials, and checking your marks.

Evaluation

Your grade for this course will be based on:

(1) Participation in Group Forums (15%)

In order to receive marks for participation, you must partake in discussion via the OWL forums throughout the term. There will be 1-2 forums with discussion questions each week, and you are expected to contribute to each (bringing in new, relevant material/insights rather than simply agreeing with/regurgitating what your peers may have already said).

There are 12 weeks worth of discussion forums, and you will be expected to both respond to, and critically engage with, the material and your peers for 10 out of 12 of the weeks. The week will begin on Monday at 12:05AM and will end on Sunday at 11:55PM. Late submissions will not be accepted, as you have 7 days to complete this task.

Note: The class will be broken down into groups of 5 (via random assignment in OWL). This will allow for more ease of engaging with your peers – rather than having to scroll and sift through 25 other students responses to the questions.

Please be kind and respectful of one another, particularly when there are sensitive topics/issues discussed or when differing opinions emerge (it was always completely fine to play “devil’s advocate” even if it is not your direct opinion).

(2) Quizzes (3 x 10% = 30%)

Quizzes are to be written individually without assistance from others. You are not restricted from using course materials in completing the quizzes; however, the quizzes are constructed such that you move through them at a steady pace, relying more on your understanding of course ideas than on having to reference course materials (in other words, you will not be given enough time to “look up” the answers and thus need to study for the quizzes). Each quiz will include 15 multiple choice questions drawn randomly from a pool of questions covering lecture, reading, and exercise material covered in each “chunk” or section of the course (in other words,

the quizzes are NOT cumulative) and the questions will be distributed evenly across the topics. On the week of a quiz, you will have between Monday at 12:00 p.m. (NOON) and Friday at 5:00 p.m. to complete your quiz. Once you begin your quiz, you will have a set amount of time to finish it. You cannot save your work and return to it later. One question will be presented at a time and you will not be able to backtrack to previous questions in your quiz. Each quiz is expected to take no more than 12 minutes to complete (averaging 45 seconds per question). All students will be allotted 20 minutes in total (from the moment you start the quiz). Consequently, students who typically require extra time accommodation will not need any special arrangement for this assessment. You cannot retake a quiz.

(3) Critical Response Assignment (20%)

This term, students will write one critical response assignment. This could include something to watch (documentary, video on YouTube), something to read (a case study, a short article (journal, newspaper, online), or something to listen to (a podcast, etc). Over the term, I will provide three different opportunities for students to submit the assignment based on pre-determined topics that will be distributed a few weeks before the deadlines. The reflection is to be 5-6 double spaced pages (APA referencing style, size 12 font, 1" margins, no additional spacing between paragraphs). Students will upload their reflections on OWL.

(4) Final Exam (35%)

The final exam will be written online via OWL and will be made up of 5-6 weeks worth of course material (this will be outlined, in detail, as the term progresses, but will cover the major themes/concepts discussed in class and not necessarily the last 5 weeks of the course). The final exam will be mixed format (multiple choice, true false, and long answer responses). Details for the final exam will be posted on OWL as soon as they are available.

1. POLICY REGARDING ACADEMIC ACCOMMODATION

Students who have long-term or chronic medical conditions which may impede their ability to complete academic responsibilities should seek Academic Accommodation through Student Accessibility Services (http://www.westerncalendar.uwo.ca/PolicyPages.cfm?PolicyCategoryID=1&Command=showCategory&SelectedCalendar=Live&ArchiveID=#Page_10).

Personal commitments (e.g., vacation flight bookings, work schedule) which conflict with a scheduled test, exam or course requirement are **not** grounds for academic accommodation.

Students who experience an illness or extenuating circumstance sufficiently severe to temporarily render them unable to meet academic requirements may submit a request for academic consideration through the following routes:

1. Submitting a **Self-Reported Absence** form provided that the conditions for submission are met;
2. For medical absences, submitting a **Student Medical Certificate (SMC)** signed by a licensed medical or mental health practitioner;
3. For non-medical absences, submitting **appropriate documentation** (e.g., obituary, police report, accident report, court order, etc.) to their Academic Advisor. Students are encouraged to contact their Academic Advisor to clarify what documentation is acceptable.

Requests for Academic Consideration Using the Self-Reported Absence Portal

Students who experience an unexpected illness or injury or an extenuating circumstance of 48 hours or less that is sufficiently severe to render them unable to meet academic requirements should self-declare using the online Self-Reported Absence portal. This option should be used in situations where the student expects to resume academic responsibilities within 48 hours. Note that the excused absence includes all courses and academic requirements within the up to 48 hours, it is not intended to provide an excused absence from a single course while students fulfill their academic responsibilities in other courses during that time.

The following conditions are in place for self-reporting of medical or extenuating circumstances:

1. Students will be allowed a **maximum of two self-reported absences** between September and April and one self-reported absence between May and August;
2. The duration of the absence will be for a maximum of 48 hours from the time the Self-Reported Absence form is completed through the online portal, or from 8:30 am the following morning if the form is submitted after 4:30 pm;
3. The excused absence will terminate prior to the end of the 48 hour period if the student undertakes significant academic responsibilities (writes a test, submits a paper) during that time;
4. Self-reported absences will **not** be allowed for scheduled final examinations; midterm examinations scheduled during the December examination period; or for final lab examinations scheduled during the final week of term;
5. Self-report absences may **not** be used for assessments worth more than 30% of any course;
6. Any absences in excess of 48 hours will require students to present a Student Medical Certificate (SMC), or appropriate documentation;
7. Students **must** communicate with their instructors **no later than 24 hours after the end of the period covered by the Self-Reported Absence form** to clarify how they will fulfil the academic expectations they may have missed during the absence.

Request for Academic Consideration for a Medical Absence

When a student requests academic accommodation (e.g., extension of a deadline, a makeup exam) for work representing 10% or more of the student's overall grade in the course, it is the responsibility of the student to provide acceptable documentation to support a medical or compassionate claim. All such requests for academic accommodation **must** be made through an Academic Advisor and include supporting documentation.

Academic accommodation for illness will be granted only if the documentation indicates that the onset, duration and severity of the illness are such that the student could not reasonably be expected to complete their academic responsibilities. Minor ailments typically treated by over-the-counter medications will not normally be accommodated.

The following conditions apply for students seeking academic accommodation on medical grounds:

1. Students must submit their Student Medical Certificate (SMC) along with a request for relief specifying the nature of the accommodation being requested no later than two business days after the date specified for resuming responsibilities. An SMC can be downloaded from http://www.uwo.ca/univsec/pdf/academic_policies/appeals/medicalform.pdf ;
2. In cases where there might be an extended absence or serious issue, students should submit their documentation promptly and consult their Academic Advisor for advice during their recovery period;
3. Whenever possible, students who require academic accommodation should provide notification and documentation in advance of due dates, scheduled tests or examinations, and other academic requirements;
4. Students **must** communicate with their instructors **no later than 24 hours** after the end of the period covered by the SMC to clarify how they will fulfil the academic expectations they may have missed during the absence;
5. Appropriate academic accommodation will be determined by the Dean's Office/Academic Advisor in consultation with the course instructor(s). Academic accommodation may include extension of deadlines, waiver of attendance requirements, arranging Special Exams (make-ups), re-weighting course requirements, or granting late withdrawal without academic penalty.

2. ACADEMIC CONCERNS

If you feel that you have a medical or personal challenge that is interfering with your work, contact your instructor and Academic Advisor as soon as possible. Problems may then be documented and possible arrangements to assist you can be discussed at the time of occurrence rather than on a retroactive basis. Retroactive requests for academic accommodation on medical or compassionate grounds are not normally considered.

If you think that you are too far behind to catch up or that your work load is not manageable, you should consult your Academic Advisor. If you consider reducing your workload by dropping one or more courses, this must be done by the appropriate deadlines; please refer to the [Registrar's website](#), <http://brescia.uwo.ca/academics/registrar-services/> or the list of official sessional dates in the Academic Calendar (<http://www.westerncalendar.uwo.ca/SessionalDates.cfm?SelectedCalendar=Live&ArchiveID=>).

You should consult with the course instructor and the Academic Advisor who can help you consider alternatives to dropping one or more courses. *Note that dropping a course may affect OSAP eligibility and/or Entrance Scholarship eligibility.*

3. ABSENCES

Short Absences: If you miss a class due to a minor illness or other problems, check your course outline for information regarding attendance requirements and make sure you are not missing a test or assignment. Cover any readings and arrange to borrow notes from a classmate. Contact the course instructor if you have any questions.

Please note that for asynchronous online courses, attendance or participation requirements maybe different than for synchronous or in-person courses.

Extended Absences: If you have an extended absence, you should contact the course instructor and an Academic Advisor. Your course instructor and Academic Advisor can discuss ways for you to catch up on missed work, and arrange academic accommodations if appropriate and warranted.

It is important to note that the Academic Dean may refuse permission to write the final examination in a course if the student has failed to maintain satisfactory academic standing throughout the year or for too frequent absence from the class or laboratory (http://www.westerncalendar.uwo.ca/PolicyPages.cfm?Command=showCategory&PolicyCategoryID=5&SelectedCalendar=Live&ArchiveID=#SubHeading_68).

4. SCHOLASTIC OFFENCES

Scholastic offences are taken seriously and students are directed to read the appropriate policy, specifically, the definition of what constitutes a Scholastic Offence at: http://www.westerncalendar.uwo.ca/PolicyPages.cfm?Command=showCategory&PolicyCategoryID=1&SelectedCalendar=Live&ArchiveID=#Page_20.

Students are responsible for understanding the nature of and avoiding the occurrence of plagiarism and other academic offences. Note that such offences include plagiarism, cheating on an examination, submitting false or fraudulent assignments or credentials, impersonating a candidate, or submitting for credit in any course without the knowledge and approval of the instructor to whom it is submitted, any academic work for which credit has previously been obtained or is being sought in another course in the University or elsewhere. Students are advised to consult the section on Scholastic Discipline for Undergraduate Students in the Academic Calendar.

If you are in doubt about whether what you are doing is inappropriate or not, consult your instructor, the Academic Dean's Office, or the Registrar. A claim that "you didn't know it was wrong" is not accepted as an excuse.

The penalties for a student guilty of a scholastic offence (including plagiarism) include refusal of a passing grade in the assignment, refusal of a passing grade in the course, suspension from the University, and expulsion from the University.

Plagiarism:

Students must write their essays and assignments in their own words. Whenever students take an idea or a passage from another author, they must acknowledge their debt both by using quotation marks where appropriate and by proper referencing such as footnotes or citations. Plagiarism is a major academic offence.

All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for the detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com (<http://www.turnitin.com>).

Computer-marked Tests/exams:

Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating. Software currently in use to score computer-marked multiple-choice tests and exams performs a similarity review as part of standard exam analysis.

5. PROCEDURES FOR APPEALING ACADEMIC EVALUATIONS

All appeals of a grade must be directed first to the course instructor. If the student is not satisfied with the decision of the course instructor, a written appeal is to be sent to the School Chair. If the response of the Chair is considered unsatisfactory to the student, they may then submit a written appeal to the Office of the Dean. If the student is not satisfied with the decision of the Dean, they may appeal to the Senate Review Board Academic (SRBA), if there are sufficient grounds for the appeal and if the matter falls within the jurisdiction of the SRBA. Note that final course marks are not official until the Academic Dean has reviewed and signed the final grade report for the course. If course marks deviate from acceptable and appropriate standards, the Academic Dean may require grades to be adjusted to align them with accepted grading practices.

6. PREREQUISITES

Unless you have either the prerequisites for a course or written special permission from the Dean to enroll in it, you will be removed from the course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisite(s).
