### **COURSE PREREQUISITES OR ANTIREQUISITES**

Antirequisite(s): French 2000E.

**Prerequisite(s):** Ontario Grade 12 French (Core, Extended, Immersion) or equivalent, or French 1010 or permission of the Department.

This course is required for a concentration in French, and is a prerequisite for French 2900, French 2600E, French 2907A/B, and French 2404A/B.

French 1910 focuses on the development of students' knowledge and use of correct grammar, syntax (sentence structure), vocabulary and pronunciation.

French 1910 is designed to enable students to increase their competency in written and oral expression, as well as to better understand and use the structures of the French language. The weekly tutorial (laboratory section 533) will concentrate on the development of students' oral expression and oral comprehension, as well as the acquisition of vocabulary.

## Note:

All students (including Francophones) are encouraged to take the Brescia Placement Test before enrolling in French 1910.

Students who have Grade 12 French but have not taken French courses for more than 3 years, should consult the Department and take the Brescia Placement Test.

## **COURSE COMPONENTS**

### **Oral presentation (Winter):**

After researching an aspect (cultural, linguistic, social, historical, etc.), particular to France or Québec, or to another Francophone collectivity, students will present, individually or in a small group (maximum 4 students), the noteworthy findings of their research. Presentations will be produced as a video and will include both an oral component (for example, narration, exposition, monologue, dialogue, conversation, etc.) and audio-visual features: for example, music, sound effects, still and moving images, graphics, text, etc.). Students will post their presentation on OWL → Forums → Présentations orales sur vidéo.

## **Composition (Winter):**

Students, individually or in pairs, will write a 300 words composition that will include a bank of specific vocabulary presented in class. Students will have a choice of types of text to choose from:

- 1) un journal ("Cher journal")
- 2) une histoire d'imagination, de mystère, de magie, de science-fiction, etc.
- 3) un voyage, vrai ou imaginé
- 4) un reportage sur un sujet au choix de l'étudiante, par exemple: les études universitaires à l'ère des restrictions imposées au contact interpersonnel entre étudiants et leurs camarades de classe et entre professeurs et étudiants, etc.
- 5) le récit d'une expérience personnelle
- 6) etc.

Students will submit their composition via OWL  $\rightarrow$  Drop Box.

## Weekly quizzes on OWL:

There are 21 OWL quizzes to complete throughout the year – please see *Fr 1910 (532 & 533)* – *le lundi et le mercredi - emploi du temps 2022-2023* below. No late submissions will be accepted.

Students will do the quizzes on OWL → Tests & Quizzes.

### Recordings (Fall & Winter):

Students' pronunciation will be tested. They will make audio files of their pronunciation of selected texts and submit their files via their individual OWL Drop Box.

#### Laboratory work: 1 oral-written comprehension test (Winter):

This test will assess students' oral and written understanding of the vocabulary presented in the laboratory component of the course. Students will access and do the test on OWL  $\rightarrow$  Tests & Quizzes.

## Grammar and vocabulary tests (1 Fall & 1 Winter):

The 2 vocabulary and grammar tests present, for the most part, the same format as the quizzes and the exercises in the coursebook: they are primarily of the fill-in the blank type of question. Students will receive a detailed description of the tests in advance to know exactly what to expect and to study for. Students will access and do the 2 tests on OWL → Tests & Quizzes.

## Final exam (April):

The 3 hour final exam is cumulative. The content of the exam will cover all the grammar points and vocabulary that will have been studied in the course. The final exam will have approximately the same format as the term tests. Details and format will be announced later.

## **Responsibilities of students:**

- If students drop the course or are absent from class, they are expected to notify the instructor in a timely manner.
- Students have the responsibility of completing the scheduled work each week: studying assigned material before lectures; completing weekly assignments, quizzes and laboratory work. In particular, missed quizzes must be completed before the deadlines and cannot be postponed, replaced or reweighted. Quizzes are accessible for a week, giving students ample time to complete them. A missed quiz (individually worth 2.1%) will receive 0. There is no possibility of doing extra work at the end of the year to compensate for missed work or unsatisfactory marks. Absent a valid reason for late submission of assigned work, or submission of incomplete work worth less than 10%, a penalty of 10% per day will be deducted up to a maximum of 5 school days, after which student work will not be accepted.
- If a student misses a term test for a valid reason that is presented to the professor in a timely manner, the value of the test will be added to the final exam.
- For any assignment or test worth 10% or more of the final grade, students must contact an academic advisor in order to obtain from him or her an official accommodation recommendation.

- Evaluate evidence to identify patterns, differences, similarities, limitations, implications, etc. and relate a particular case to a general (grammatical, phonetic) rule.

- Analyze one's own limitations and weaknesses, find the appropriate available information (in dictionary, grammar books, internet, etc.) to complement and develop knowledge and skills.
- Use and apply specific methods and (grammar, pronunciation) rules and vocabulary which were studied in class appropriately.
- Seek help when needed (ask questions to the professor, go to the writing center, etc.).
- Compare different strategies (visual, auditory...) for managing and mastering information.

#### 1. POLICY REGARDING ACADEMIC ACCOMMODATION

Students who have long-term or chronic medical conditions which may impede their ability to complete academic responsibilities should seek Academic Accommodation through Student Accessibility Services

(https://www.westerncalendar.uwo.ca/PolicyPages.cfm?Command=showCategory&PolicyCategoryID= 1&SelectedCalendar=Live&ArchiveID=#Page\_10).

Personal commitments (e.g., vacation flight bookings, work schedule) which conflict with a scheduled test, exam or course requirement are **not** grounds for academic accommodation.

Students who experience an illness or extenuating circumstance sufficiently severe to temporarily render them unable to meet academic requirements may submit a request for academic consideration through the following routes:

- 1. For medical absences, submitting a **Student Medical Certificate** (**SMC**) signed by a licensed medical or mental health practitioner;
- 2. For non-medical absences, submitting **appropriate documentation** (e.g., obituary, police report, accident report, court order, etc.) to their Academic Advisor. Students are encouraged to contact their Academic Advisor to clarify what documentation is acceptable.

#### Request for Academic Consideration for a Medical Absence

When a student requests academic accommodation (e.g., extension of a deadline, a makeup exam) for work representing 10% or more of the student's overall grade in the course, it is the responsibility of the student to provide acceptable documentation to support a medical or compassionate claim. All such requests for academic accommodation **must** be made through an Academic Advisor and include supporting documentation.

Academic accommodation for illness will be granted only if the documentation indicates that the onset, duration and severity of the illness are such that the student could not reasonably be expected to complete their academic responsibilities. Minor ailments typically treated by over-the-counter medications will not normally be accommodated.

The following conditions apply for students seeking academic accommodation on medical grounds:

- Students must submit their Student Medical Certificate (SMC) along with a request for relief specifying the nature of the accommodation being requested no later than two business days after the date specified for resuming responsibilities. An SMC can be downloaded from

- In cases where there might be an extended absence or serious issue, students should submit their documentation promptly and consult their Academic Advisor for advice during their recovery period;

- 3. Whenever possible, students who require academic accommodation should provide notification and documentation in advance of due dates, scheduled tests or examinations, and other academic requirements;
- 4. Students **must** communicate with their instructors **no later than 24 hours** after the end of the period covered by the SMC to clarify how they will fulfil the academic expectations they may have missed during the absence;
- Appropriate academic accommodation will be determined by the Dean's Office/Academic Advisor in consultation with the course instructor(s). Academic accommodation may include extension of deadlines, waiver of attendance requirements, arranging Special Exams (make-ups), re-weighting course requirements, or granting late withdrawal without academic penalty.

#### 2. ACADEMIC CONCERNS

If you feel that you have a medical or personal challenge that is interfering with your work, contact your instructor and Academic Advisor as soon as possible. Problems may then be documented and possible arrangements to assist you can be discussed at the time of occurrence rather than on a retroactive basis. Retroactive requests for academic accommodation on medical or compassionate grounds are not normally considered.

If you think that you are too far behind to catch up or that your work load is not manageable, you should consult your Academic Advisor

You should consult with the course instructor and the Academic Advisor who can help you consider alternatives to dropping one or more courses. *Note that dropping a course may affect OSAP eligibility and/or Entrance Scholarship eligibility.* 

#### 3. ABSENCES

**Short Absences:** If you miss a class due to a minor illness or other problems, check your course outline for information regarding attendance requirements and make sure you are not missing a test or assignment. Cover any readings and arrange to borrow notes from a classmate. Contact the course instructor if you have any questions.

Please note that for asynchronous online courses, attendance or participation requirements maybe different than for synchronous or in-person courses.

**Extended Absences:** If you have an extended absence, you should contact the course instructor and an Academic Advisor. Your course instructor and Academic Advisor can discuss ways for you to catch up on missed work, and arrange academic accommodations if appropriate and warranted.

#### 4. SCHOLASTIC OFFENCES

Students are responsible for understanding the nature of and avoiding the occurrence of plagiarism and other academic offences. Note that such offences include plagiarism, cheating on an examination, submitting false or fraudulent assignments or credentials, impersonating a candidate, or submitting for credit in any course without the knowledge and approval of the instructor to whom it is submitted, any academic work for which credit has previously been obtained or is being sought in another course in the University or elsewhere. Students are advised to consult the section on Scholastic Discipline for Undergraduate Students in the Academic Calendar.

If you are in doubt about whether what you are doing is inappropriate or not, consult your instructor, the Academic Dean's Office, or the Registrar. A claim that "you didn't know it was wrong" is not accepted as an excuse.

The penalties for a student guilty of a scholastic offence (including plagiarism) include refusal of a passing grade in the assignment, refusal of a passing grade in the course, suspension from the University, and expulsion from the University.

## Plagiarism:

Students must write their essays and assignments in their own words. Whenever students take an idea or a passage from another author, they must acknowledge their debt both by using quotation marks where appropriate and by proper referencing such as footnotes or citations. Plagiarism is a major academic offence.

All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for the detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com.

#### **Computer-marked Tests/exams**:

Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating. Software currently in use to score computer-marked multiple-choice tests and exams performs a similarity review as part of standard exam analysis.

#### 5. PROCEDURES FOR APPEALING ACADEMIC EVALUATIONS

All appeals of a grade must be directed first to the course instructor. If the student is not satisfied with the decision of the course instructor, a written appeal is to be sent to the School Chair. If the response of the Chair is considered unsatisfactory to the student, they may then submit a written appeal to the Office of the Dean. If the student is not satisfied with the decision of the Dean, they may appeal to the Senate Review Board Academic (SRBA), if there are sufficient grounds for the appeal and if the matter falls within the jurisdiction of the SRBA. Note that final course marks are not official until the Academic Dean has reviewed and signed the final grade report for the course. If course marks deviate from acceptable and appropriate standards, the Academic Dean may require grades to be adjusted to align them with accepted grading practices.

#### 6. Prerequisites

Unless you have either the prerequisites for a course or written Special Permission from the Dean to enroll in it, you will be removed from the course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisite(s).
