Description prise du calendrier universitaire

Through the study of the cultural productions from the 17th Century in France, students will deepen their knowledge of specific productions as well as of critical approaches to them in order to be able to formulate their own critical perspectives and to communicate them effectively and accurately orally and in writing.

Prérequis pour FR3570G : FR2600E ou (FR2605F/G et FR2606FG)

Description et objectifs du cours

Si pour les sociologues, la réputation est un domaine de recherche émergent¹, pour les littéraires, les réflexions sur la réputation ont déjà fait couler beaucoup d'encre depuis des siècles. À l'Antiquité, les philosophes tels Platon, Aristote et Plutarque présentent leurs traités moraux; à la Renaissance, les auteurs définissent le bon comportement du prince, du gentilhomme, de la femme. La réputation implique une évaluation (*reputatio,-onis* : examen, méditation, réflexion), c'est-à-dire qu'il s'agit d'un jugement de valeur sociale et morale.

Au cours du semestre, nous allons explorer la notion de la réputation (voir aussi «*fama*» et «renommée») dans la littérature du XVII^e siècle français. Qui dit réputation, dit «statut, prestige, estime, légitimité, honneur, notoriété, reconnaissance, renom, gloire, célébrité, visibilité.»² Ce concept alors polysémique nous permettra d'évaluer les notions du bon ou mauvais comportement, la circulation des bruits, des rumeurs et de la médisance, et la précarité sociale de l'individu. Pour ce faire, nous considérerons les conséquences de la calomnie sur la réputation d'une femme dans *La Mariane* de Tristan L'Hermite. Ensuite, nous lirons quelques *Historiettes* de Tallemant des Réaux pour découvrir la relation triangulaire entre le sujet-l'auteur-le public d'une rumeur. Enfin, par notre lecture de *La Princesse de Clèves* de Madame de Lafayette, nous

examinerons les codes de bienséances qui régissent les relations interpersonnelles et servent à définir le comportement honnête, voire vertueux au Grand Siècle.

Objectifs pédagogiques/Compétences transférables

French 3570F est un cours interactif qui oblige la participation active de chaque étudiant.e. À la fin de ce cours, les étudiant.e.s devront être capables de :

- Identifier et définir les caractéristiques principales de la tragédie et du roman au XVII^e siècle.
- Définir la fonction sociale de la rumeur, de la médisance et de la calomnie.
- Formuler et partager leurs propres opinions et critiques littéraires par le biais de discussions et de projets collaboratifs.
- Acquérir de meilleures compétences d'esprit critique.
- Enrichir leur vocabulaire passif et actif.
- Identifier les principales figures de style (la comparaison, la métaphore, l'allusion, etc.).
- Employer de nouveaux modes de communication (l'explication de texte, le compte rendu critique, la dissertation littéraire, etc.).

Explication du barème

Tests : Les tests inscrits au programme serviront de contrôle de connaissances sur les éléments d'intrigue, les personnages et leurs motivations, la structure et le genre des œuvres. Le premier test de 20 mins contrôlera la compréhension de base (qui, quoi, où, pourquoi?); le deuxième test de 1h30 sera plus compréhensif et posera des questions liées aux thématiques du cours et des questions d'analyse stylistique et rhétorique. Puisque l'objectif du test est d'assurer que chaque étudiant.e lit les œuvres du corpus, les tests auront lieu avant que nous ne parlions des textes en classe.

Explication de texte : Seul.e ou avec un.e partenaire, les étudiant.e.s prépareront une présentation écrite sur un monologue tiré de *La Mariane* de Tristan. Ils/elles montreront par cet exercice leur capacité d'expliquer l'important de l'extrait (ses figures de style, sa structure, le sens du texte) en utilisant uniquement des exemples du passage. Il ne s'agit pas ici d'une interprétation du texte, mais une analyse neutre.

Historiette : Pour ce devoir, il s'agit d'un exercice d'écriture créative/création littéraire. Seul.e ou avec un.e partenaire, les étudiant.e.s rédigeront une historiette racontant un épisode intéressant de la vie d'une personne célèbre. En imitant le style de Tallemant, les étudiant.e.s emprunteront des éléments thématiques ou rhétoriques de l'auteur pour traiter d'un sujet contemporain.

Captone (la dissertation littéraire) : À la fin du semestre, les étudiant.e.s prépareront et rendront une dissertation qui examinera la femme tragique. L'objectif principal de ce devoir est de considérer une/des œuvres de notre corpus à la lumière de la recherche critique (des sources secondaires). Ce devoir se complétera au cours des dernières semaines du cours par le biais d'une approche échafaudée (*scaffolded approach*).

Entretien (1-on-1) : Lors d'une rencontre individuelle avec la professeure, les étudiant.e.s définiront leur sujet et leur hypothèse à voix haute. Le but de l'entretien est d'énoncer informellement son plan et son objectif à l'aide d'un feedback instantané de Mme Kirk. La note s'attribuera en fonction de la clarté d'expression et la préparation de l'étudiant.e.

Compte rendu critique : Seul.e ou avec un.e partenaire, les étudiant.e.s analyseront et critiqueront un article savant concernant le théâtre du XVII^e siècle. Ils/elles résumeront brièvement les arguments principaux, identifieront la thèse et enfin détermineront si l'auteure réussit à bien prouver sa thèse. L'article sera choisi par la professeure et sera disponible sur OWL.

Évaluation par des pairs : Notre séance d'examen par des pairs aura lieu pendant la première heure de cours en classe. Les étudiant.e.s échangeront un brouillon complet de sa dissertation avec un.e camarade qui le lira, le commentera et le critiquera pour que tout le monde puisse rendre la meilleure version définitive possible.

Engagement actif : Cette note sera accordée en fonction de l'assiduité, la préparation, la participation et le respect de l'étiquette de classe de l'étudiant.e (il est interdit de dormir, de regarder des films, de texter, ou de déranger la classe. Prière de ranger vos portables avant le début du cours). Les étudiant.e.s rendront aussi des tickets de sortie hebdomadaires par lesquels on répondra à une question de réflexion liée à la discussion du jour ou à l'article critique à l'étude.

NB. : Les retards prolongés ou les départs avant la fin de la classe seront notés comme des absences. Chaque absence vaut une perte d'un demi-pourcentage (ex. 4 absences = -2 %).

All assignments submitted on time will be returned promptly (within three weeks of submission) and will include, on return, written annotations, corrections, and general commentary. It is understood that we can study and analyse history while including consideration of what is offensive and why, within the context of reasoned discussion and civil debate. Please contact the professor for details or if you have any questions. As a cis-gendered, educated, white woman, I might be unaware of my privileges or biases when presenting certain subjects: please do not hesitate to politely point out omissions, missteps, or blind spots so that I can learn and grow as a scholar and citizen.

Email : In most cases, I will not address course content questions by email. If you have any questions regarding lessons, definitions, texts, etc., please see me during my office hours in person, on Zoom, or by appointment. I will also not respond to blank message (messages without a greeting, a brief message, and a signature) as I feel that writing a professional email is an important skill to master during your studies.

Copyright and Intellectual Property: All content including, but not limited to videos, audiofiles, lists of readings, in-class activities, assignment guidelines, and other components of the course materials are typically the intellectual property of the instructor. Unauthorized reproduction through audio-recording, video-recording, photographing, sharing on social media, or posting on course-sharing websites is an infringement of copyright and is prohibited. Such action may be considered a Code of Conduct violation and lead to sanctions.

Hardware, software, Internet connection : Preparing your computer for class is your responsibility. The technical requirements of this course include a computer, the ability to type French accents (all accent mistakes are counted), internet access, a personal back-up solution for your notes and your assignments. Your @uwo.ca ID entitles you to 1TB of storage through OneDrive. There is no excuse not to back-up your material.

Technical difficulties are not considered grounds for late or absent submissions. Since technological issues can and do happen, please make sure that you complete and submit your assignments well before the cut off time.

Online Tests and Exams: Online learners are held to the same Code of Conduct as on campus. When you are completing assignments remotely, I trust that you will complete the assignment with the same attention to detail and ethical behaviour as you would in class. Thus, you should not seek outside help to complete an assignment, test, or exam unless otherwise indicated.

Some tests and exams are metered and cannot be interrupted. So, make sure that you have a quiet place in which to complete the exercise. Turn off your phone (so that you won't be distracted by messages and notifications), quit your email application, and turn off any pop ups that might impede your progress. You should consider restarting your computer before taking a test online and launching only the browser needed to complete the activity.

Final Grades : Please note that grades cannot be adjusted on the basis of need (for progression in a programme, for graduation, for a scholarship, etc.). Your mark in the course is always the mark that you earn. It is not possible to resubmit assignments to obtain a higher mark; there are no extra credit assignments. If you feel dissatisfied with a grade or feel that you have been unduly penalised, you have the right to appeal your grade as per the University's Senate Regulations, a right I respect (See below: Academic Policies, note 5).

1. POLICY REGARDING ACADEMIC ACCOMMODATION

Students who have long-term or chronic medical conditions which may impede their ability to complete academic responsibilities should seek Academic Accommodation through Student Accessibility Services

(https://www.westerncalendar.uwo.ca/PolicyPages.cfm?Command=showCategory&PolicyCategoryID=1&SelectedCalendar=Live&ArchiveID=#Page_10).

Personal commitments (e.g., vacation flight bookings, work schedule) which conflict with a scheduled test, exam or course requirement are **not** grounds for academic accommodation.

Students who experience an illness or extenuating circumstance sufficiently severe to temporarily render them unable to meet academic requirements may submit a request for academic consideration through the following routes:

1. For medical absences, submitting a **Student Medical Certificate (SMC)** signed by a licensed medical or mental health practitioner;
2. For non-medical absences, submitting **appropriate documentation** (e.g., obituary, police report, accident report, court order, etc.) to their Academic Advisor. Students are encouraged to contact their Academic Advisor to clarify what documentation is acceptable.

Request for Academic Consideration for a Medical Absence

When a student requests academic accommodation (e.g., extension of a deadline, a makeup exam) for work representing 10% or more of the student's overall grade in the course, it is the responsibility of the student to provide acceptable documentation to support a medical or compassionate claim. All such requests for academic accommodation **must** be made through an Academic Advisor and include supporting documentation.

Academic accommodation for illness will be granted only if the documentation indicates that the onset, duration and severity of the illness are such that the student could not reasonably be expected to complete their academic responsibilities. Minor ailments typically treated by over-the-counter medications will not normally be accommodated.

The following conditions apply for students seeking academic accommodation on medical grounds:

1. Students must submit their Student Medical Certificate (SMC) along with a request for relief specifying the nature of the accommodation being requested no later than two business days after the date specified for resuming responsibilities. An SMC can be downloaded from
https://www.uwo.ca/univsec/pdf/academic_policies/appeals/medicalform.pdf;
2. In cases where there might be an extended absence or serious issue, students should submit their documentation promptly and consult their Academic Advisor for advice during their recovery period;
3. Whenever possible, students who require academic accommodation should provide notification and documentation in advance of due dates, scheduled tests or examinations, and other academic requirements;

4. Students **must** communicate with their instructors **no later than 24 hours** after the end of the period covered by the SMC to clarify how they will fulfil the academic expectations they may have missed during the absence;
5. Appropriate academic accommodation will be determined by the Dean's Office/Academic Advisor in consultation with the course instructor(s). Academic accommodation may include extension of deadlines, waiver of attendance requirements, arranging Special Exams (make-ups), re-weighting course requirements, or granting late withdrawal without academic penalty.

2. ACADEMIC CONCERNs

If you feel that you have a medical or personal challenge that is interfering with your work, contact your instructor and Academic Advisor as soon as possible. Problems may then be documented and possible arrangements to assist you can be discussed at the time of occurrence rather than on a retroactive basis. Retroactive requests for academic accommodation on medical or compassionate grounds are not normally considered.

If you think that you are too far behind to catch up or that your work load is not manageable, you should consult your Academic Advisor

If you consider reducing your workload by dropping one or more courses, this must be done by the appropriate deadlines; please contact your Academic Advisor or see the list of sessional dates in the Academic Calendar

You should consult with the course instructor and the Academic Advisor who can help you consider alternatives to dropping one or more courses. *Note that dropping a course may affect OSAP eligibility and/or Entrance Scholarship eligibility.*

3. ABSENCES

Short Absences: If you miss a class due to a minor illness or other problems, check your course outline for information regarding attendance requirements and make sure you are not missing a test or assignment. Cover any readings and arrange to borrow notes from a classmate. Contact the course instructor if you have any questions.

Please note that for asynchronous online courses, attendance or participation requirements maybe different than for synchronous or in-person courses.

Extended Absences: If you have an extended absence, you should contact the course instructor and an Academic Advisor. Your course instructor and Academic Advisor can discuss ways for you to catch up on missed work, and arrange academic accommodations if appropriate and warranted.

It is important to note that the Academic Dean may refuse permission to write the final examination in a course if the student has failed to maintain satisfactory academic standing throughout the year or for too frequent absence from the class or laboratory

4. SCHOLASTIC OFFENCES

Students are responsible for understanding the nature of and avoiding the occurrence of plagiarism and other academic offences. Note that such offences include plagiarism, cheating on an examination, submitting false or fraudulent assignments or credentials, impersonating a candidate, or submitting for credit in any course without the knowledge and approval of the instructor to whom it is submitted, any academic work for which credit has previously been obtained or is being sought in another course in the University or elsewhere. Students are advised to consult the section on Scholastic Discipline for Undergraduate Students in the Academic Calendar.

If you are in doubt about whether what you are doing is inappropriate or not, consult your instructor, the Academic Dean's Office, or the Registrar. A claim that "you didn't know it was wrong" is not accepted as an excuse.

The penalties for a student guilty of a scholastic offence (including plagiarism) include refusal of a passing grade in the assignment, refusal of a passing grade in the course, suspension from the University, and expulsion from the University.

Plagiarism:

Students must write their essays and assignments in their own words. Whenever students take an idea or a passage from another author, they must acknowledge their debt both by using quotation marks where appropriate and by proper referencing such as footnotes or citations. Plagiarism is a major academic offence.

All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for the detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com.

Computer-marked Tests/exams:

Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating. Software currently in use to score computer-marked multiple-choice tests and exams performs a similarity review as part of standard exam analysis.

5. PROCEDURES FOR APPEALING ACADEMIC EVALUATIONS

All appeals of a grade must be directed first to the course instructor. If the student is not satisfied with the decision of the course instructor, a written appeal is to be sent to the School Chair. If the response of the Chair is considered unsatisfactory to the student, they may then submit a written appeal to the Office of the Dean. If the student is not satisfied with the decision of the Dean, they may appeal to the Senate Review Board Academic (SRBA), if there are sufficient grounds for the appeal and if the matter falls within the jurisdiction of the SRBA. Note that final course marks are not official until the Academic Dean has reviewed and signed the final grade report for the course. If course marks deviate from acceptable and

appropriate standards, the Academic Dean may require grades to be adjusted to align them with accepted grading practices.

Unless you have either the prerequisites for a course or written Special Permission from the Dean to enroll in it, you will be removed from the course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisite(s).
